RE: Addition of a revised "Provincial HIV Case Report Form" and a new "HIV Partner or Contact Notification Form" to Chapter 6 Surveillance of Reportable

Conditions, Disease-Specific Provincial Surveillance Forms, Sexually Transmitted

& Blood Borne Infections

(1) Provincial HIV Case Report Form - Revised

For all new HIV positive cases diagnosed January 1, 2021 onward, please use the revised *Provincial HIV Case Report Form – October 2020.* The 2013 Provincial HIV Case Report Form (version date: 2013/01/11) can continue to be used for all cases prior to and including December 31, 2020.

Please note the following changes to the revised *Provincial HIV Case Report Form – October 2020*:

- Preamble added describing the reason for collecting ethnicity/race and other demographics
- Update to questions regarding **Indigenous** identity to align with data standards
- Update to response options for which gender a person identifies with
- Addition of question regarding pregnancy status
- Addition of diagnosis by HIV viral load
- Updated response options to Motivation for HIV testing
- More robust Risk Factors & Exposure Information section
- Interventions section expanded to include mental health and alcohol use
- Partner notification section simplified and streamlined
- Re-ordering of questions to improve flow

(2) HIV Partner or Contact Notification Form – New

This form can be used by public health nurses as an adjunct to the HIV Case Report Form. It is intended to be used as a support tool or template to guide Partner or Contact notification and services for individuals who have been identified by an index case as being at risk of exposure to HIV during the trace-back period. This form does not need to be submitted to BCCDC.
