- RE: Revisions to the Communicable Disease Control (CDC) Manual Chapter 5: Sexually Transmitted Infections: Section 2: HIV/AIDS

Please note the following changes to the Communicable Disease Control (CDC) Manual – Chapter 5: Sexually Transmitted Infections: Section 2: HIV/AIDS

(1) HIV/AIDS – Updated. Please discard and replace the following sections with *Guidelines for Testing, Follow up, and Prevention of HIV (August 2016)*:

- HIV Pre and Post Test Guidelines (September 2011)
- HIV Laboratory Testing: A Resource for Health Professionals (June 2010)
- HIV-1, HIV-2 Counselling and Follow Up Policy (October 2007)

Changes in Guidelines for Testing, Follow up, and Prevention of HIV (2016) include:

- Recommendations that are aligned with the Ministry of Health strategic framework: *From Hope to Health: Towards and Aids Free Generation*.
- Testing window periods updated to reflect the fourth-generation HIV screening test currently used in BC.
- Reference to point of care HIV testing.
- Information regarding acute HIV infection, including information on how to order HIV RNA qualitative nucleic acid amplification testing (NAAT) to detect acute HIV infection.
- Updates to the section on follow up of new HIV diagnoses to align with current practice, including the practice of urgent follow up of HIV diagnoses in the acute stage of infection.
- Addition of a new section, *Prevention of HIV Acquisition and Transmission*, to describe strategies to prevent HIV infection and to highlight the societal, structural, community, and behavioral factors influencing HIV infection, as described in the PHO Report "HIV, Stigma, and Society"¹
