# Part 2 - Immunization of Special Populations

### Other High Risk Conditions:

## Infants at High Risk for Hepatitis B

- This section has been revised to align with the BC Communicable Disease Control Manual, Chapter 1, Hepatitis B and has been separated into 2 documents:
  - o Infants at High Risk for Hepatitis B
  - High Risk Neonatal Hepatitis B Immunization Program (letter for health care providers)
- Content revised to include:
  - Additional details related to the risk of infants developing hepatitis B infection, becoming chronic carriers and the effectiveness of hepatitis B post-exposure prophylaxis (PEP).
  - o Recommendations for maternal antiviral treatment.

### Perinatal Protocols for Hepatitis B has been revised as follows:

- PHSA Laboratory Services renamed BCCDC Public Health Laboratory (BCCDC PHL).
- The BCCDC PHL process for HBsAg positive perinatal lab results has been described.
- Recommendations for hepatitis B virus DNA testing have been added.
- Documentation procedures for HBsAg positive results, as well as HBIG and hepatitis B vaccination at birth have been outlined.
- For home deliveries, the process for midwives to obtain HBIg and hepatitis B vaccine has been described.

- Renamed "Prophylaxis Indications for Infants at High Risk of Hepatitis B".
- Removed content related to the Hospital Case Room faxing the completed form to the health unit office as this process is no longer required. As such, the client information and check indication column have been removed.
- Minor content revisions have been made under "Indications".
- Content related to hepatitis B vaccine series and post-vaccination testing of infants has been added along with a link to the BC Communicable Disease Control Guidelines, Chapter 1, Hepatitis B for case management.
