COVID-19 Vaccines

COVID-19 mRNA Vaccine BNT162b2 (Pfizer-BioNTech)

- Footnote A has been added to indicate that minimum age for vaccine receipt is based on year of birth (i.e., individuals who will be turning 16 years of age within the current calendar year), per Provincial Health Officer (PHO) recommendations.
- Footnote B has been updated to indicate that while the vaccine series should be completed with the same COVID-19 vaccine product, if the product used for the first dose is unknown or unavailable, the second dose may be given with an available mRNA product.

COVID-19 mRNA Vaccine mRNA-1273 (Moderna)

- Footnote A has been added to indicate that minimum age for vaccine receipt is based on year of birth (i.e., individuals who will be turning 18 years of age within the current calendar year), per PHO recommendations.
- Footnote B has been added to indicate that adolescents 16-17 years of age who are <u>clinically extremely vulnerable</u> may receive the Moderna vaccine if the Pfizer-BioNTech product is unavailable, per PHO recommendations.
- Footnote C has been updated to indicate that while the vaccine series should be completed with the same COVID-19 vaccine product, if the product used for the first dose is unknown or unavailable, the second dose may be given with an available mRNA product.

COVID-19 Vaccine (ChAdOx1-S [recombinant]) (AstraZeneca/COVISHIELD)

- The recommended age indication has been revised to 40 years of age and older, per PHO recommendations. The minimum age for vaccine receipt is based on year of birth (i.e., the vaccine may be offered to individuals who will be turning 40 years of age within the current calendar year), per BC Government recommendations.
- Storage and Handling recommendations have been clarified to indicate that while the vial
 can be re-refrigerated after first vial puncture, the cumulative storage time at room
 temperature must not exceed 6 hours, and the *total* cumulative storage time must not
 exceed 48 hours. Once 48 hours after first puncture has been reached, the vial must be
 discarded.
