Re: Revisions to the Communicable Disease Control Manual –

**Chapter 2, Immunization Program** 

Please note the following revisions to the Communicable Disease Control Manual, Chapter 2 – Immunization Program:

**SECTION VII, BIOLOGICAL PRODUCTS -**

Pages 24 and 25, "Human Papillomavirus Vaccine (GARDASIL™)":

- Revisions have been made for the implementation of the Grade 6 girls' extended HPV vaccine schedule. The first two doses will be given in grade 6 with a minimum interval of 6 months between doses. The third dose will be given in grade 11.
- The BC Communicable Disease Policy Advisory Committee (CDPAC)
  reviewed the results at 24 months of a study of two doses given at 0 and 6
  months to girls aged 9-13 years. The CDPAC recommended this schedule for
  girls in grade 6 in the BC program. The third dose is being planned to ensure
  sustained protection into sexually active years of life.
- The extended HPV schedule will be offered ONLY to girls entering grade 6 in September 2010 and as part of the ongoing grade 6 HPV vaccine program in subsequent years. This decision was made for programmatic reasons and to ensure that the extended schedule can be completed before the girls' graduation.

Administrative Circular 2010:17



- Grade 6 girls who are known to have immune system defects associated with solid organ transplant, stem cell transplant, or HIV infection should receive HPV vaccine in the three dose schedule at 0, 2 and 6 months. The immunosuppressed state results in a less robust immune response and those with such conditions are at risk of persistent HPV infection and associated HPV disease if they become infected.
- Grade 9 girls will be given 3 doses of HPV vaccine using the 0, 2, and 6 month schedule. The final year of the HPV grade 9 program starts in September 2010; these girls will continue to receive the routine 3 dose schedule in order to complete the series while in grade 9.
- All females older than grade 6 should be vaccinated on the 0, 2, and 6 month schedule. Girls that missed the vaccine series in grades 6 or 9 and that present later for vaccine should be offered HPV vaccine according to the 0, 2, and 6 month schedule.
