## Bexsero ${ }^{\circledR}$ Meningococcal B Vaccine (four component recombinant, adsorbed vaccine)

Pages have been added to reflect the availability of Meningococcal B Vaccine. Currently the vaccine is only provided free to contacts of a case of serogroup B invasive meningococcal disease and, in consultation with BCCDC, during IMD outbreaks caused by $N$. meningitidis serogroup $B$. The page also lists groups for whom the vaccine is recommended but not provided free including individuals with certain medical conditions, certain lab and military personnel, and travelers to endemic areas.

The guidelines also include recommendations for the prophylactic administration of acetaminophen to control fever in infants and children under the age of two years. The use of acetaminophen with meningococcal B vaccine has not been found to reduce the immunogenicity of this vaccine.
